## RESOLUTION NUMBER 2021-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA, EXTENDING A LOCAL STATE OF EMERGENCY AND PROVIDING FOR EMERGENCY GOVERNMENTAL OPERATIONS RELATED TO THE NOVEL CORONAVIRUS DISEASE 2019 ("COVID-19").

## **RECITALS**

WHEREAS, based on the recommendation of the Public Safety Emergency Manager and the County Administrator in response to the potential public health threat posed by COVID-19, the Board of County Commissioners of Charlotte County, Florida issued a Resolution declaring a local state of emergency (LSE) on March 17, 2020, and thereafter extended the local state of emergency by Resolutions dated March 24, 2020; March 31, 2020, April 7, 2020, April 14, 2020, April 21, 2020, April 28, 2020, May 5, 2020, May 12, 2020, May 19, 2020, May 26, 2020, June 2, 2020, June 9, 2020, June 16, 2020, June 23, 2020, June 30, 2020, July 7, 2020, July 14, 2020, July 21, 2020, July 28, 2020, August 4, 2020, August 11, 2020, August 18, 2020, August 25, 2020, September 1, 2020, September 8, 2020, September 15, 2020, September 22, 2020, September 29, 2020, October 6, 2020, October 13, 2020, October 20, 2020, October 27, 2020, November 3, 2020, November 10, 2020 November 17, 2020, November 24, 2020, December 1, 2020, December 8, 2020, December 15, 2020, December 22, 2020, December 29, 2020, January 5, 2021, January 12, 2021, January 19, 2021, January 26, 2021, February 2, 2021, February 9, 2021, February 16, 2021, February 23, 2021, March 2, 2021, March 9, 2021, March 16, 2021, March 23, 2021, March 30, 2021, April 6, 2021, April 13, 2021, April 20, 2021, April 27, 2021, May 4, 2021, May 11, 2021, May 18, 2021, May 25, 2021, June 1, 2021, June 8, 2021, and June 15, 2021; and

**WHEREAS**, in the time since the original Resolution was adopted, the Board has found it necessary to extend the LSE, and the threat to the public health posed by COVID-19 presently continues to require dynamic emerging response, including the maintenance of existing orders and the ability to impose additional orders as conditions require.

**NOW THEREFORE**, in accordance with the emergency power vested in the County pursuant to Chapter 252, Florida Statutes, and Chapter 2-1of the Charlotte County Code of Ordinances, it is hereby proclaimed that:

Section 1. The local state of emergency declared on March 17, 2020, and extended thereafter is hereby extended for an additional 7 days from the effective date of this Resolution, unless terminated or modified earlier or extended in accordance with law.

<u>Section 2</u>. The County will continue to recognize and adhere to directives and guidance issued by the Center for Disease Control and Florida Department of Health.

Section 3. All emergency powers authorized by the Resolution of March 17, 2020, declaring a local state of emergency and any extension, are hereby retained and continued for the duration of this Resolution.
