RE: 2025-2026 Continued Funding Request

Dear Commissioners:

We want to take this opportunity to thank you for your commitment to the provision of funding that we utilize to serve legal aid clients throughout Charlotte County. This letter serves to indicate our interest and letter of intent to continue this partnership in FY 2025-2026.

Florida Rural Legal Services (FRLS) is requesting FY 2025-2026 funding to support the current legal aid services we provide in Charlotte County. FRLS also requests consideration for a funding increase for 2025-2026 to increase the level of services we can provide or for consideration to maintain the current level of funding at a minimum if an increase is not possible for this cycle. The proposed increase in funding will ensure that FRLS can continue to provide free legal assistance to Charlotte County.

Between October 2023 and September 2024, FRLS closed 451 cases and opened 535 cases for residents of Charlotte County. FRLS currently has 73 open client cases. FRLS provided 2,745,47 hours of services to clients living in Charlotte County. FRLS assisted clients with obtaining needed public benefits, divorce and family protection, guardianships, housing and homelessness prevention. Many of our clients are faced with several obstacles and often have more than one legal issue. FRLS provides holistic legal services and community outreach services to address those needs.

Between October 2023 and September 2024, FRLS helped Charlotte County clients save or recover over \$298,333.57 dollars in lump sum recoveries and debt avoidances. FRLS also reached over 500 people through more than 200 outreach events conducted in Charlotte County in



the last year. The funding we receive is helping us to positively impact the lives of Charlotte County residents.

The economic climate low-income households are currently navigating has increased the need for legal aid services as indigent individuals and vulnerable families face economic hardships that result in food insecurity, risk of becoming unhoused, increased domestic violence, mental health issues, and a need for public benefits.

FRLS has been leading the war against poverty in Florida since 1966. We are the gateway for free civil legal assistance to low-income populations and the only provider of comprehensive migrant worker free civil legal aid statewide. FRLS will continue to provide free legal representation to the residents in need in Charlotte County through this partnership.

FRLS remains dedicated to the mission of serving low income and vulnerable populations. We are certain with the continued support of our partners and funders, we will continue to expand our high-quality legal services while also working with our pro-bono partners to expand our reach of service to those in need.
