A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA, GRANTING SOUTHWEST ENGINEERING A PLANNED DEVELOPMENT (PD) MODIFICATION TO THE FINAL DETAIL SITE PLAN APPROVAL FOR CBHC SUBSTANCE ABUSE TREATMENT BUILDING EXPANSION (DRC-PD-90-7), CONSISTING OF A 11,431 SQUARE FOOT KITCHEN AND OFFICE BUILDING, SIDEWALK, PARKING, AND A STORMWATER MANAGEMENT FACILITY, ON A 0.729± ACRE SITE, LOCATED AT 1700 EDUCATION AVENUE, PUNTA GORDA, FLORIDA, IN COMMISSION DISTRICT II.

RECITALS

WHEREAS, Southwest Engineering ("Applicant") submitted Application DRC-25-111 requesting a Planned Development (PD) Modification to the Final Detail Site Plan Approval for CBHC Substance Abuse Treatment Building Expansion (DRC-PD-90-7), consisting of a 11,431 square foot kitchen and office building, sidewalk, parking, and a stormwater management facility, on a 0.729± acre site, located at 1700 Education Avenue, Punta Gorda, Florida, in Commission District II, and more particularly described in Exhibit "A" attached hereto ("Property"); and

WHEREAS, the Property was rezoned to Planned Development (PD) on December 18, 1990, pursuant to Resolution Number 90-314, along with its associated PD conditions; and

WHEREAS, the Charlotte County Site Plan Review committee reviewed Application DRC-25-111 for technical compliance with the Code of Laws and Ordinances of Charlotte County, Florida ("Code") and finds it to be generally consistent with Charlotte County's Comprehensive Plan, the Code, and other applicable guidelines; and

WHEREAS, the Board has reviewed Application DRC-25-111 and the findings of the Site Plan Review committee.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Charlotte County, Florida ("Board"):

1. Application DRC-25-111 is approved with the following conditions which must be met by the Applicant:

- A. As required by Code Section 3-9-45(d)(4)(d), the projected schedule for the development approved by this Resolution from commencement to buildout shall be as follows:
 - i. Commencement shall begin after approval by the Board.
 - ii. Buildout shall be substantially completed prior to October 28, 2028.
- B. Development standards shall comply with Resolution Number 90-314, as may be amended by the Board.

2. The effective date of this Resolution shall be the date this Resolution is recorded.
