## RECITALS

WHEREAS, County Staff has determined that Chapter 3-7, Subdivision Regulations, of the Code of Laws and Ordinances of Charlotte County, Florida ("Code") contains some outdated requirements and regulations, and must be updated to align with Florida Statutes, as well as meet the requirements of new legislation under Senate Bill 784, approved by the Governor on June 20, 2025; and

WHEREAS, at this time, in order to remedy the outdated requirements and regulations to align with Florida Statutes and the above-mentioned new

- legislation, County Staff, in Petition TLDR-25-01, is proposing amendments to Chapter 3-7 of the Code, all as provided in Exhibit "A" which is attached hereto
- and by this reference provided herein; and

- WHEREAS, Petition TLDR-25-01 was heard by the Charlotte County
  Planning and Zoning Board ("P&Z Board") and, based on the findings and
  analysis provided by County Staff and the evidence presented to the P&Z Board,
  the P&Z Board recommended approval on September 8, 2025; and
  - WHEREAS, after due consideration, based on the findings and analysis provided by County Staff and the evidence presented to it, the Board finds that approval of Petition TLDR-25-01 is consistent with the County's Comprehensive Plan and is in the best interests of the County and its citizens.
  - NOW, THEREFORE, BE IT ORDAINED by the Board of County
    Commissioners of Charlotte County, Florida:
    - Section 1. Adoption. Chapter 3-7, Subdivision Regulations, of the Code of Laws and Ordinances of Charlotte County, Florida, is hereby amended by adding the underlined language and by deleting the stricken language as shown in Exhibit "A" which is attached hereto and by this reference provided herein.
  - Section 2. Conflict with Other Ordinances. The provisions of this Ordinance shall supersede any provision of existing ordinances in conflict herewith to the extent of said conflict.
- Section 3. Severability. If any subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be

64	deemed a separate, distinct, and independent provision and such holding shall
65	not affect the validity of the remainder of this Ordinance.
66	Section 4. Effective Date. This Ordinance shall take effect upon
67	filing in the Office of the Secretary of State, State of Florida.

## Sec. 3-7-32. – Application Process

Step 8: The appropriate county department shall secure the signatures of the county engineer, county surveyor, county attorney, <u>Community Development Director</u>, and chairman of the board of county commissioners. Required signatures will be secured only if all other requirements have been satisfied.

Step 9: Final plat approval: The county shall not issue approval of a final plat for recording with any conditions or stipulations. The appropriate county department will secure the appropriate chairman's signature on the record mylar and other required documents. The appropriate county department shall deliver the plat, bond, construction and maintenance agreement, and other documents to the clerk of the circuit court for recording.

## Sec. 3-7-34. - Approval of the Final Plat

After determination by the county attorney and county engineer that the final plat is in conformance with this chapter, it shall be the ministerial duty of the <u>Community Development Director to sign the mylar and the chairman of the board of county commissioners to sign the mylar and the construction and maintenance agreement, if applicable, after all other required signers have signed.</u>
