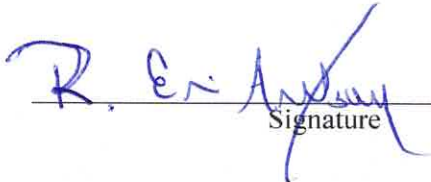

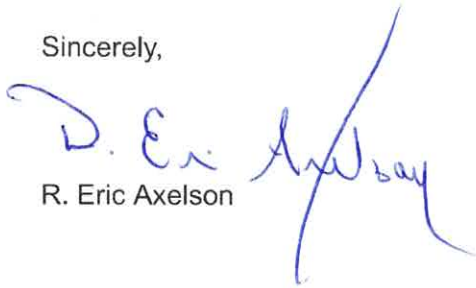
I am applying to serve on the West County Stormwater Advisory Board. I know the Chair and that they need volunteer members.
