A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA; APPROVING AND ADOPTING ADJUSTED RATES FOR NONRESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL; PROVIDING AN EFFECTIVE DATE.

RECITALS

WHEREAS, the Board of County Commissioners, on June 17, 2025, considered a report recommending adjustments to landfill fees (also known as "tipping" fees); and

WHEREAS, the Board, after consideration of the presentation, determined that the rates, fees, and charges for disposal at the County landfill should be adjusted; and

WHEREAS, the Board finds that the proposed disposal rates depicted in Exhibit "A" are in the best interest of the County, its residents, visitors, ratepayers and taxpayers.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Charlotte County, Florida that:

1. The adjusted Nonresidential Solid Waste Collection Rates, contained in Exhibit "A," which is attached and made part of this Resolution, are hereby adopted.

2. The adjusted rates adopted in this Resolution shall take effect on January 1, 2026. The rate for Fiscal Year 2029, unless subsequently amended, shall remain in effect after imposition until the Board of County Commissioners further amends the adjusted disposal rates.

3. This Resolution shall become effective immediately upon its passage and adoption.


