A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA, RESCINDING RESOLUTION 2025-253; AUTHORIZING THE EXECUTION OF CERTAIN COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATIONS BY THE COUNTY ADMINISTRATOR OR HIS OR HER DESIGNEE; AND PROVIDING AN EFFECTIVE DATE.

RECITALS

WHEREAS, the Charlotte County Board of County Commissioners has the authority to apply for and receive grants from federally funded programs, administered by the State of Florida; and

WHEREAS, the State of Florida has been allocated federal funding to support long-term disaster recovery through the Community Development Block Grant - Disaster Recovery (CDBG-DR) and Community Development Block Grant – Mitigation (CDBG-MIT) appropriation; and

WHEREAS, CDBG-DR and CDBG-MIT funding may be used for eligible infrastructure activities that addresses unmet needs resulting from a declared disaster or that benefit the low-to moderate-income community; and

WHEREAS, Resolution 2025-253 authorizes the County Administrator, or his/her designee, to execute certain grant applications related to CDBG-DR and CDBG-MIT funding in response to Hurricanes Debbie, Idalia, Helene, and Milton; and

WHEREAS, the Board desires to amend the list of storms for which the delegated authority applies; and

WHEREAS, such grant applications contain schedules requiring submittals by certain dates, usually representing an extremely short time frame; and

WHEREAS, authorizing the County Administrator, or his/her designee, to execute CDBG-DR and CDBG-MIT grant applications for timely submission to the grantor serves the best interests of the citizens of Charlotte County; and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Charlotte County, Florida:

Section 1. Resolution 2025-253 is hereby rescinded.

Section 2. The County Administrator, or his/her designee, is hereby authorized to execute, and/or sign all grant applications related to CDBG-DR and CDBG-MIT funding in response to Hurricanes Ian, Debbie, Idalia, Helene, and Milton.

Section 3. This Resolution shall be effective upon adoption.

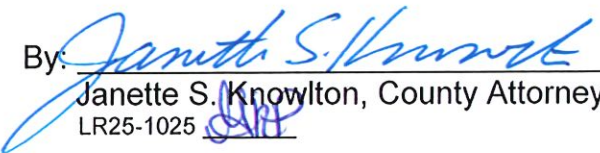
