

**AMENDMENT #3 TO CONTRACT NO. 2011000079
BETWEEN CHARLOTTE COUNTY
and
MUELLER SYSTEMS, LLC
for
AUTOMATED METER READING SYSTEM**

THIS AMENDMENT #3 to Contract No. 2011000079 (“Amendment #3”) is made and entered into by and between CHARLOTTE COUNTY, a political subdivision of the State of Florida, 18500 Murdock Circle, Port Charlotte, Florida 33948-1094 (the “County”), and MUELLER SYSTEMS, LLC, 10210 Statesville Boulevard, Cleveland, North Carolina 27013 (the “Vendor”).

RECITALS

WHEREAS, the County and the Vendor entered into Contract No. 2011000079 (the “Agreement”) on or about January 3, 2012, to provide and maintain a fixed-base automated meter reading system, with a contract term through September 30, 2023; and

WHEREAS, on or about August 11, 2015, the parties entered into Amendment #1 to the Agreement, to provide additional labor and other services necessary to facilitate an accelerated deployment of the Automated Meter Reading System; and

WHEREAS, on or about September 26, 2016, the parties entered into Amendment #2 to the Agreement to add Supplementary Conditions necessary for contracts funded utilizing State Revolving Fund (“SRF”) financing; and

WHEREAS, the parties now wish to amend the Agreement to extend its term through September 30, 2025, to revise the price schedule to provide for guaranteed pricing through 2025, and to revise the hosting fees for FY 2025.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the County and the Vendor agree as set forth below:

ARTICLE I
GUARANTEED MAXIMUM PRICE

- 1.1. The recitals above are incorporated herein by reference.
- 1.2. The term of the Agreement is hereby extended to September 30, 2025.
- 1.3. The unit prices for services are hereby revised as provided for in **Exhibit A**, Pricing Schedule, which is incorporated into and made part of the Agreement.
- 1.4. The Hosting Fee for fiscal year 2025 is hereby revised as set forth on **Exhibit B**, Hosting Fees 2025, which is incorporated into and made part of the Agreement.

ARTICLE II
MISCELLANEOUS

- 2.1. The effective date of this Amendment #3 is the date on which it is signed by both parties.
- 2.2. Any terms used in this Amendment #3 shall have the same meanings and definitions as they have in the Agreement.
- 2.3. All other provisions of the Agreement and Amendments #1 and #2 not in conflict with this Amendment #3 shall remain in full force and effect.


