





ESTIMATES OF TIMESCALE

Project Example: Standalone Commercial Retail Building

ESTIMATES OF PERMIT VOLUME

As a seasoned engineering consulting firm, including plans reviews and inspections, UES has performed plans reviews for various municipalities throughout South Florida.

Due to the nature of our building inspections services, and our sizable, capable staff, we have considered permit volume in terms of hours spent versus specific capacities.

Dependent upon the situation, our review capabilities may vary. For example, if a full building is assigned for permit reviews, our services may take up to five (5) days. If smaller assignments are provided, our reviews may be completed in anywhere from 2-20 hours.

This timeframe may be influenced by the following factors:

1. Regulatory Requirements

Local zoning, environmental, or floodplain regulations affecting review timelines.

2. Permit Submission Quality

Completeness and compliance of applications received may influence the volume we are able to review. For instance, submitted permits with all required documentation, may streamline the process.

3. Staffing Levels and Workload Distribution

UES' Fort Myers location employs a robust building inspections and plan review team, capable of addressing a variety of workloads. We are able to allocate staff as needed to respond to local government needs. Additionally, we employ staff who are familiar with Charlotte County's building department processes and regulations, which may streamline our reviews further.



2. Inform employees about the dangers of drug abuse in the workplace, the business's policy of maintaining a drug-free workplace, any available drug counseling, rehabilitation, and employee assistance programs, and the penalties that may be imposed upon employees for drug abuse violations.
3. Give each employee engaged in providing the commodities or contractual services that are under bid a copy of the statement specified in subsection (1).
4. In the statement specified in subsection (1), notify the employees that, as a condition of working on the commodities or contractual services that are under bid, the employee will abide by the terms of the statement and will notify the employer of any conviction of, or plea of guilty or nolo contendere to, any violation of Chapter 893 or of any controlled substance law of the United States or any state, for a violation occurring in the workplace no later than five (5) days after such conviction.
5. Impose a sanction on or require the satisfactory participation in a drug abuse assistance or rehabilitation program if such is available in the employee's community, by any employee who is so convicted.
6. Make a good faith effort to continue to maintain a drug-free workplace through implementation of this section.
