AMENDMENT #1 TO CONTRACT NO. 2019000557 BETWEEN CHARLOTTE COUNTY and FLORIDA PREMIER CONTRACTORS, LLC for CONSTRUCTION MANAGER AT RISK

THIS AMENDMENT #1 to Contract No. 2019000557 (the "Amendment") is made and entered into by and between CHARLOTTE COUNTY, a political subdivision of the State of Florida, 18500 Murdock Circle, Port Charlotte, Florida 33948-1094 (the "County"), and FLORIDA PREMIER CONTRACTORS, LLC., 25450 Airport Road, Suite A, Punta Gorda, Florida 33950 (the "Construction Manager" or "CM").

RECITALS

WHEREAS, the County and the Construction Manager entered into Contract No. 2019000557 (the "Agreement") on or about November 14, 2019, to engage the Construction Manager for preconstruction and construction services for the Placida Boat Ramp West (the "Project"); and

WHEREAS the Construction Manager has been providing, and is capable of continuing to provide, the necessary project services; and

WHEREAS, the County desires to add additional Preconstruction services associated with the Placida Boat Ramp West; and

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the County and the Construction Manager agree as set forth below:

ARTICLE I COMPENSATION / SERVICES

- 1.1. The following provisions of this Amendment #1, and Exhibit A, Prime Contract Change Order, attached hereto, are specifically incorporated into and made a part of the Contract;
- 1.2. The Scope of Services for the Project is hereby amended as described in **Exhibit A**, to include additional preconstruction CM at Risk services associated with the Placida Boat Ramp West;
- 1.3. The Construction Manager shall provide the additional services as described in Exhibit A, and the County shall pay an amount not to exceed Eighty-Two Thousand Fifty-Three Dollars (\$82,053.00) for these services;
- 1.4 The additional services shall be provided concurrently with other Project services, within the timeframe as previously established.

ARTICLE II MISCELLANEOUS

2.1. The effective date of this Amendment is the date on which it is signed by

both parties.

- 2.2. Any terms used in this Amendment shall have the same meanings and definitions as they have in the Agreement.
- 2.3. All other provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
