AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA, PURSUANT TO SECTION 163.3184, FLORIDA STATUTES, AMENDING THE COUNTY'S COMPREHENSIVE PLAN BY AMENDING CHARLOTTE COUNTY FLUM SERIES MAP #1: 2030 FUTURE LAND USE FROM AGRICULTURE (AG) TO MINERAL RESOURCE EXTRACTION (MRE); FOR PROPERTY LOCATED AT 2650 SR 31, IN THE PUNTA GORDA AREA AND WITHIN THE EAST COUNTY AREA; CONTAINING 223.14± ACRES; CHARLOTTE COUNTY, FLORIDA, COMMISSION DISTRICT I; PETITION PAL-23-00005; APPLICANT: LAKE LONELY, LLC; PROVIDING AN EFFECTIVE DATE; AND PROVIDING FOR TRANSMITTAL OF ADOPTED ORDINANCE.

RECITALS

WHEREAS, applicant, Lake Lonely, LLC ("Applicant"), filed Petition PAL-23-00005, seeking a large scale plan amendment to the County's Comprehensive Plan by amending Charlotte County FLUM Series Map #1: 2030 Future Land Use from Agriculture (AG) to Mineral Resource Extraction (MRE), for property located at 2650 SR 31, in the Punta Gorda area and within the East County area, containing 223.14 acres more or less ("Property"), and more particularly described in Exhibit "A" attached hereto; and

WHEREAS, on May 12, 2025, Petition PAL-23-00005 was heard before the Charlotte County Planning and Zoning Board ("P&Z Board") and, based on the findings and analysis provided by County Staff and the evidence presented to the P&Z Board, Petition PAL-23-00005 was found to be consistent with the County's Comprehensive Plan and the P&Z Board recommended approval for transmittal of Petition PAL-23-00005 to the Florida Department of Commerce and other state agencies for review; and

35 WHEREAS, in a public hearing held on Tuesday, June 10, 2025, the Board of
36 County Commissioners of Charlotte County, Florida ("Board") reviewed plan amendment
37 Petition PAL-23-00005 and, based on the findings and analysis provided by County Staff
38 regarding the amendment and the evidence presented to the Board, approved transmittal
39 of Petition PAL-23-00005 to the Florida Department of Commerce and other state agencies
40 for review and comment; and

41 WHEREAS, Petition PAL-23-00005 was transmitted to the Florida
42 Department of Commerce and other state agencies for review and comment; and

43 WHEREAS, the comments received by the reviewing agencies, if any, have
44 been considered and addressed by the Applicant and incorporated into the findings and
45 analysis provided by County Staff; and

46 WHEREAS, after due consideration regarding Petition PAL-23-00005 in a
47 public hearing held on September 9, 2025, and based on the findings and analysis
48 presented to the Board, the Board finds that the proposed amendment is consistent with
49 the County's Comprehensive Plan, and that the requirements of Chapter 163, Florida
50 Statutes, as they relate to the Petition have been met, and that it is in the best interests of
51 the County and its citizens to approve Petition PAL-23-00005.

52 NOW, THEREFORE, BE IT ORDAINED by the Board of County
53 Commissioners of Charlotte County, Florida:

54 Section 1. Approval. Petition PAL-23-00005 requesting a large scale plan
55 amendment to the County's Comprehensive Plan by amending Charlotte County FLUM
56 Series Map #1: 2030 Future Land Use, from AG to MRE, for property located at 2650
57 SR 31, in the Punta Gorda area and within the East County area, containing 223.14 acres

58 more or less, Charlotte County, Florida, Commission District I, and more particularly
59 described in Exhibit "A" attached hereto and by this reference incorporated herein, is
60 hereby approved.

61 Section 2. Effective date. The effective date of this plan amendment, if the
62 amendment is not timely challenged, shall be 31 days after the state land planning agency
63 notifies the local government that the plan amendment package is complete. If timely
64 challenged, this amendment shall become effective on the date the state land planning
65 agency or the Administration Commission enters a final order determining this adopted
66 amendment to be in compliance. No development orders, development permits, or land
67 uses dependent on this amendment may be issued or commence before its effective date.

68 Section 3. Transmittal. County Staff is hereby directed to forward a copy of
69 this Ordinance and its attachments to the Florida Department of Commerce, 107 East
70 Madison Street, Tallahassee, FL 32399-4120, and to the Executive Director, Southwest
71 Florida Regional Planning Council, 1400 Colonial Boulevard, Suite 1, Fort Myers, FL
72 33907.

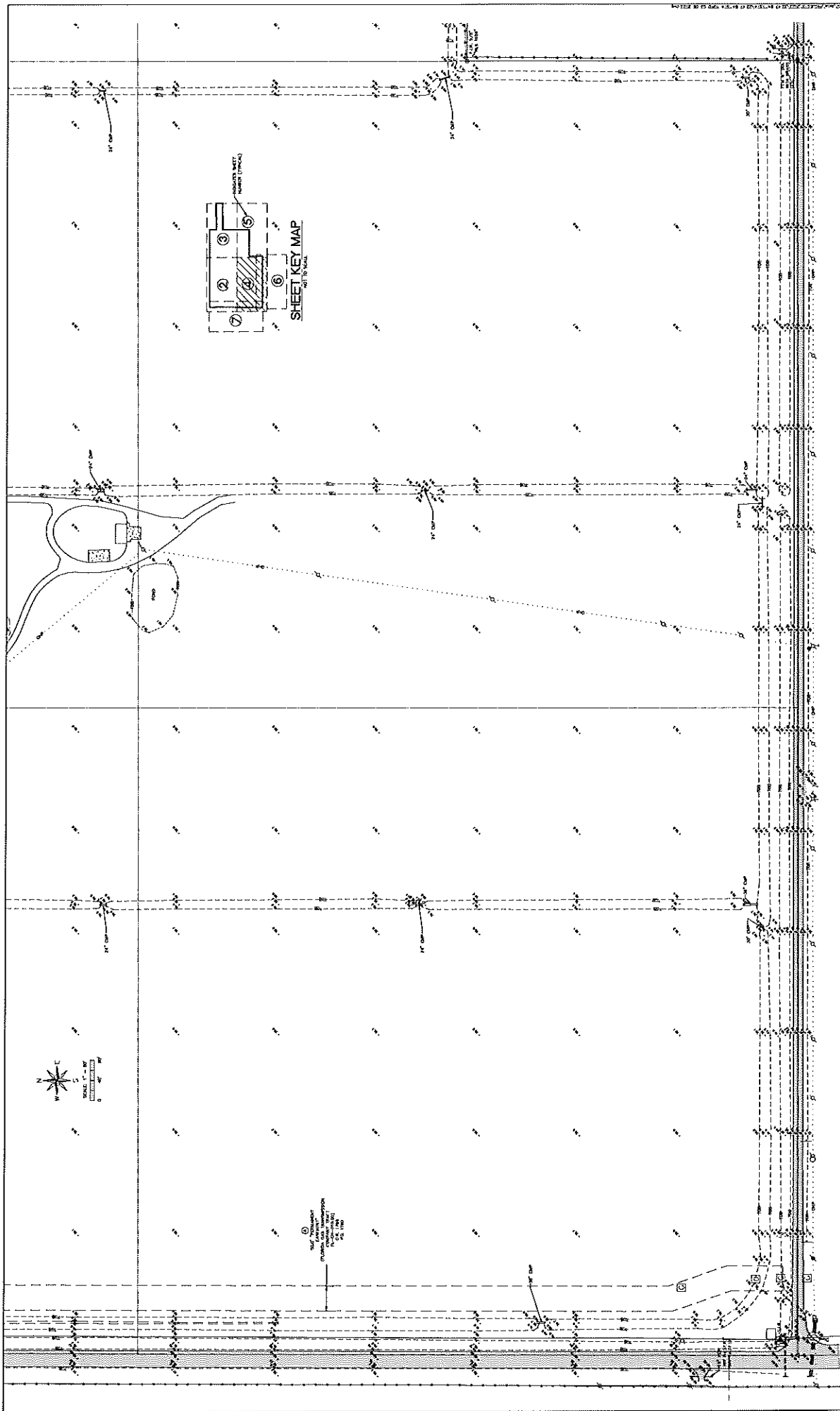

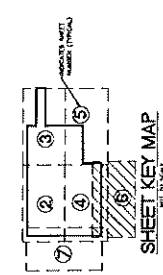
