

ECONOMIC/BUSINESS IMPACT ESTIMATE

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA; PURSUANT TO SECTION 2-4-41, OF THE CODE OF LAWS AND ORDINANCES OF CHARLOTTE COUNTY, FLORIDA; AMENDING THE SPEED LIMITS ON DON PEDRO ISLAND IN CHARLOTTE COUNTY, FLORIDA; PROVIDING FOR PENALTIES FOR VIOLATION; PROVIDING THAT THE SPEED LIMIT IS NOT AFFECTED BY NAME OR ROAD DESIGNATION CHANGE; PROVIDING FOR CONFLICT WITH OTHER ORDINANCES; PROVIDING FOR INCORPORATION OF EXHIBITS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

PUBLIC PURPOSE:

This ordinance aims to enhance the safe and efficient flow of vehicular and pedestrian traffic in Don Pedro Island.

- * Ordinances relating to the adoption/amendment/funding of the budget;
- * Ordinances relating to F.S. Chapter 163, growth policy, LDR's, zoning.

You do NOT need to complete *Part B, Business Impact*, for the following types of ordinances:

- * Ordinances required for compliance with federal/state law/regulation;
- * Ordinances relating to issuance/refinancing of debt;
- * Ordinances required to implement a contract/agreement such as any grant or other financial assistance accepted by the county;
- * Ordinances relating to procurement;
- * Ordinances relating to CDD's, including their
 establishment/termination/contraction/expansion;
- * Ordinances relating to the Florida Building Code or Fire Prevention Code.

All other ordinances require both Parts A and B to be completed.
