Public Input

Michael Lonigro discussed Ackerman Sewer Project cost increases and phases, annual assessment rates, available funding sources, and tax payer impacts.

Phillip Smallwood mentioned Burnt Store Water Reclamation Facility (WRF) capacity and operators, portable unit cost, and funding and connection fee responsibility.

Sharon Wright, HDR Florida Resilience Practice Lead gave a brief overview of Resiliency & Modernization Program: Public Meeting 2 of 2, About Charlotte County Utilities Department (CCU), About CCU, Utility & Regulatory Drivers, Resiliency & Modernization Program (R&M), R&M Program: Grant Compliance, Outcomes & Benefits to Community, Tailored Decision-Support Framework, Interactive and Iterative Workshop Process, Project Prioritization Rubric, Program Prioritization, Prioritization Framework Applied, Capital Improvement Projects (CIP) & Capital Maintenance Program (CMP) Prioritization - How Projects Stack Up, R & M Implementation, Funding Sources and Strategies, Prioritization Framework - Performance Measure Scoring Tool, Resilient Infrastructure, Charlotte County Utilities Department 20 year Capital Improvement and Maintenance Plan Projects, Project Locations, Project: East Port WRF Deep Well Supply Line, Education and Training, R&M Part of CCU Communication Plan, Summary, and responded to Draft Integrated Master Plan.

Chair Tiseo commented on Resiliency & Modernization Program: Public Meeting 2 of 2, public input requirement, Grant qualification, Summary, storm surge events, criteria, Project: East Port WRF Deep Well Supply Line, compliance issues, Prioritization Framework Applied, CityWorks, decision making process, objectivity, and Draft Integrated Master Plan. Commissioner Constance spoke to Prioritization Framework Applied, scoring calculation methodology, Project Prioritization Rubric, subjective and objective ratings, Live Oak Point Park, Project: East Port WRF Deep Well Supply Line, database ownership and updates, and Draft Integrated Master Plan. Commissioner Doherty noted Project Prioritization Rubric, weightings technique implementation, and adjustment flexibility.

County Attorney Knowlton interjected on public input requirement.

Deputy County Attorney Thomas David responded to Grant public input requirement.

Richard Arthur, Fiscal Services Manager gave a brief overview of Agenda and Timeline.

3. Connection Fee Discussion

Murray Hamilton, Raftelis Vice President gave a brief overview of Discussion Topics, Purpose and Background, Project Tasks, Summary of Current Fees with Emphasis on "TAP Fee", Capacity Fee Criteria: Governed primarily by Florida Case Law, Cost Allocation Approach, Cost Recovery Methods, Development of Capacity Fees, Existing CCU Assets, Apportionment of Capital Projects, Water System Improvements, Wastewater System Improvements, Summary of Available Capacities, System-wide Service Level, Investment in Existing Plant Facilities, Investment in Plant Capacity Additions, Investment in Transmission Facilities, Summary of Plant and Transmission Capacity Fee Results, Why Capacity Fees Differ Among Utilities, Capacity Fee Comparison, Accrued Guaranteed Revenue Fee (AGRF) Criteria, Summary of AGRF Fee Results, Water Connection Fee Results, and replied to financing alternatives.

Chair Tiseo discussed water and wastewater expansion project costs, infrastructure, Florida Association of Counties (FAC), construction inflation, existing rate payers, cost allocation and recovery, new development fees, septic to sewer expansion

program and costs, comparative analysis, Water Connection Fee Results, Wastewater Connection Fee Results, full cost approach, and Capacity Fee Comparison. **Commissioner Constance** mentioned Existing CCU Assets, Water System Improvements, line extension requests and connection fees, AGRF, rate payers and impacts, system utilization and maintenance, connection fee cost indexing, Wastewater Connection Fee Results, inflation, construction costs, Low Pressure Sewer Systems (LPS), and 3 Million Gallons Per Day (MGD) cost calculations. **Commissioner Deutsch** commented cost. **Commissioner Doherty** spoke to Water System Improvements, 3 MGD and Reservoir 3 costs, Surface Water Supply Expansion Project (SWSEP), Wastewater Connection Fee Results, Water Connection Fee Results, line extension charges, LPS tanks, and full cost and indexing approaches. **Commissioner Truex** noted petroleum cost impacts, debt, full cost approach, LPS locations, Cape Haze, and indexing.

Mr. Arthur remarked on Reservoir 3 expansion, cost estimates, Water System Improvements, Timeline, connection fees, indexing, and full cost approach.

County Administrator Flores replied to cost estimates and Water System Improvements.

Sandra Weaver, Business Services Supervisor gave a brief overview of Paymentus: Terminology, Payment Options, July Paymentus - Payment by Method, August Paymentus - Payments by Method, Assuming E-Check (\$1) Fees, Account Shutoffs, replied to fee-free alternatives, and convenience fees.

Chair Tiseo discussed State Road 776 Wastewater Force Main, lateral installation, Change Order #1, adequate drainage design criteria and determination standards, Change Order #2, Change Order #3, communication improvements, design professionals and consultants, Change Order #5, change order language and reason, contingency fund uses, backup documentation, contract markup percentage process, East Port Headworks Option 2 and total project cost, engineers and CCU cost estimates, Ackerman Septic to Sewer customer assessment, Payment Options, fee-free alternatives, July Paymentus - Payments by Method, surrounding counties comparative analysis, Pinellas County contract, Bill Pay setup and payment process, Assuming E-Check (\$1) Fees, cash flow value, transaction volume and fees, and SCADA Fiber Optic Upgrades. Commissioner Constance mentioned Change Order #5, infrastructure removal costs, change order language

and process, detailed associated costs and suggestion source spreadsheet, Change Order #8, documentation, East Port Headworks design and Request for Proposal (RFP), contract amendment, Lakeview/Midway - Water Quality Improvement, Paymentus contract term, payment processing options, and SCADA Fiber Optic Upgrades. Commissioner Deutsch commented on change order details and reason, General Development, and cost increases. Commissioner Doherty spoke to East Port Water Reclamation Facility Expansion, Change Order #8, implementation timeline extension, and language, project and construction costs, East Port Headworks, Change Order #1, change order approval process, delivery system selection, Construction Manager at Risk (CMAR) proposals, East Port Headworks Option 2, Lakeview/Midway - Water Quality Improvement, LPS systems, funding sources, Meadow Park Elementary School, Engineering Design Manual Update, and pump station classifications and elevations. Commissioner Truex noted State Road 776 Wastewater Force Main existing line extension, Change Order #5, Agenda item backup documentation, project agreement change process and management, unidentified infrastructure, General Development, contractor responsibility, McKim & Creed back credit, Bid 2023-485 and Change Order #8 documentation, time extensions, East Port Headworks cost estimates and 90% drawings, and Automated Clearing Housing (ACH) payments.

Tom Friedrich, Jones Edmunds Senior Consultant remarked on staffing change impacts, adequate drainage determination, East Port Headworks, Change Order #1, unidentified existing infrastructure, Change Order #3, change order process and time extensions, Change Order #5, contractor proposal, Change Order #8 language and reason, Poole & Kent Company of Florida, Bid 2023-485 documents and specifications, McKim & Creed, East Port Headworks system improvements, cost estimates, and structural and electrical designs.

Kim Corbett, Purchasing Senior Division Manager responded to October 14, 2025 Regular Meeting, Bid 2023-485 East Port Water Reclamation Facility Expansion Change Order #8 backup documentation and original package, and SCADA Fiber Optic Upgrades.

County Administrator Flores replied to needed process improvements.

Dave Watson, Utilities Director remarked on Jones Edmunds East Port Headworks Contract amendment.

Mr. Arthur responded to Ackerman Septic to Sewer Conversion assessment and Municipal Service Benefit Unit (MSBU) term extension.

Assistant County Administrator Claire Jubb replied to Payments contract term, November 18, 2025 Board Workshop, credit card fee management, RFP, Engineering Design Manual Update, and regulations.

County Attorney Knowlton interjected on Engineering Design Manual Update.

Lewis Bryant, Kimley-Horn & Associates Professional Engineer gave a brief overview of Agenda, Needs Assessment, Future Expansion Needs, Alternatives Descriptions: Alternative 1, Alternative 2, Alternative 3, Alternative 4, Tentative Cost/Schedules, Recommendation, and Today's Request to the Board.

Commissioner Constance discussed unit purchase and rental costs and Florida Power & Light (FPL) involvement. **Commissioner Doherty** mentioned Alternative 4, Tentative Cost/Schedules, unit purchase, and cost reduction. **Commissioner Truex** commented on project cost reduction.

Nathan Claussen, Haskell Project Director responded to Alternative 4, engineer probable cost opinion, unit purchase costs, and required additional infrastructure and functional processes.

Dave Watson, Utilities Director replied Utilities Department Quarterly Update and project updates.

Ms. Corbett responded to unit purchase credit and Amendment #1 cost reduction revision.

6. Advanced Metering Infrastructure (AMI) Update

Rick Hitzemann, E Source Operational Technology Director gave a brief overview of Agenda, E Source Introduction, Advanced Metering Infrastructure (AMI) System Components to Aid Discussion, Goals for the AMI System, Initial Study Findings - Deficiencies, Additional Findings and Actions Taken, Read Success Rate Over the Past Year, and Recommended Action Plan.

Chair Tiseo remarked on AMI Study, alternative solutions, pilot program period, surrounding counties comparison, and technology comparison. Commissioner Constance spoke to AMI System Components to Aid Discussion, meter reading process, Additional Findings and Actions Taken, battery life expectancy, FP&L electric meter technology, cooperative agreements, purchase and maintenance costs, environmental resiliency, methodology comparisons, and Automated Meter Reading (AMR). Commissioner Doherty noted AMI Study, Mueller contract, meter and equipment failures, operational improvements, and alternatives. Commissioner Truex discussed Mueller, meter replacement and installation responsibility, inaccurate reading revenue loss and improvements, staffing costs, technology, and alternatives.

Mr. Watson replied to Mueller contract period, meter replacement responsibility and alternative compatibility, AMI Roadmap, flexibility, initial system and maintenance costs, and infrastructure review.

Mr. Watson gave a brief overview of Monthly Purchases from Water Authority Average Daily Per Month, Water Produced at Burnt Store Average Daily Per Month, Reclaimed Distributed, Water Distribution, Water Service Installs, Wastewater/Reclaim Events, Sanitary Sewer Overflows Per Calendar Year, Contractor Hits Per Calendar Year, Source of Sanitary Sewer Overflows (SSOs): July 2024 - August 2025, Cause of SSOs: July 2024 - August 2025, Customers Per Sewer System Type, Water Reclamation Facilities Percent of Capacity - Last 12 Months, New Customers, Burnt Store WRF Remaining Equivalent Residential Connections (ERCs), East Port WRF Remaining ERCs, West Port WRF Remaining ERCs, Rotonda WRF Remaining ERCs, Peace River System, Burnt Store System, Miscellaneous Data, Business Services, Accounts Turned off for Non-payment, Customer Support Data, Public Relations, Employee Performance Measures, Department Overtime, 2026 Utility Topics, responded to Florida Department of Environmental Protection (FDEP) requirements, and developer capacity fees.

Chair Tiseo mentioned Burnt Store WRF Remaining ERCs, capacity reservation fees and availability, development projects, threshold, and availability letters. **Commissioner Constance** commented on connection costs and reserved capacity. **Commissioner Truex** spoke to undeveloped properties and reserved capacity.
