

Specifically with respect to appropriations issues, Kari possesses the experience, access, and insights into all facets of the state budget process, has knowledge of legislative and executive branch appropriation protocols and extensive knowledge of the appropriations maze and criteria for evaluating funding requests.

Having formerly represented the Florida Association of Counties for seven years, Kari is strategically positioned to represent the needs of Charlotte County. With her past involvement, she is familiar with the myriad of competing demands at the county-level and possesses the knowledge to address them head-on at the state level. Kari's prior experience positions her and the team as uniquely qualified to drive Charlotte County's agenda.

Success Rate

Kari prides herself on providing excellent customer service and has been extremely successful in the legislative, appropriations, regulatory, and communications arena for her clients.

In the construction arena, Kari has been the lead on the construction industry building code bill for the last decade, spearheading the legislation that becomes the "catch-all" for construction and contractor issues including Chapter 489, F.S., and related Chapter 556, F.S., Chapter 558, F.S., and Chapter 633, F.S., revisions. Furthermore, Kari has successfully passed comprehensive legislation relating to affordable housing, including the "Live Local Act," impact fees, inclusionary zoning and linkage fees.

V. Ability to Meet County's Needs, Methodology, and Approach

We will begin our representation of Charlotte County by conducting initial meetings with the Board of County Commissioners to review legislative goals and analyze the most efficient ways of meeting them as well as identify potential challenges.

Technical Approach

The Carlton Fields team will employ a "SWOT" analysis approach, identifying Strengths, Weaknesses, Opportunities and Threats in the development and implementation of Charlotte County's government relations agenda. Working closely with the Charlotte County staff, Carlton Fields will help identify those policy initiatives that should be prioritized along with the specific project funding requests based on the economic climate, political will of the Legislature and the Executive Branch, and the possible needs to develop consensus with other counties and local governments.

Once the Charlotte County's legislative agenda and funding requests have been determined, the Carlton Fields team will schedule and meet with committee staff directors and staff analysts, budget and appropriations committee chairs and staff. Meetings with the governor's staff and appropriate personnel at various state agencies will also be established pre-session to share policy and budget requests and garner support. Communication with Legislative and Executive branch staff will be on-going throughout the legislative session.

Moreover, we will meet with other industry stakeholders including the Florida Association of Counties and the Florida League of Cities, as well as lobbyists for similarly-situated counties to collaborate, build consensus and a strong coalition for Charlotte County's legislative agenda.

In addition, meetings with potential bill sponsors and the Charlotte delegation will be scheduled and executed to build support and develop "champions" for Charlotte County's priorities. We will secure bill sponsors and co-sponsors to carry Charlotte County's legislative agenda. We will schedule meetings with committee members serving on the committees to which Charlotte County's legislative and funding priorities will be referred. We will also advise the Charlotte County Board of County Commissioners as to when they may be required to come to Tallahassee to meet with legislators to discuss legislative priorities and schedule said meetings when necessary.

With input from the Board and the County Administrator, the Carlton Fields team will develop white papers, "talk sheets," or "leave-behind" one-page documents outlining Charlotte County's issues that will be distributed to lawmakers. Further messaging may take the form of press conferences or media events with bill sponsors and like-minded stakeholders, and social media posts utilizing X, Facebook, or LinkedIn.

We will work to ensure Charlotte County's legislative initiatives are scheduled for committee hearings, and we will meet with the bill sponsors, provide written talking points for each sponsor's presentation and be prepared to testify on behalf of Charlotte County's before the committee.



Monitoring

In addition to actively monitoring legislative committee meetings, agency meetings and floor sessions in the Florida House of Representatives and Florida Senate, Carlton Fields employs numerous databases and resources to track legislation, agency rules and budget issues in real time. If engaged, we will add Charlotte County's legislative interests to our tracking database. We will provide summaries of bills of interest to Charlotte County on a timely basis. We will also monitor the appropriations process and other state funding opportunities on behalf of the County.

Communications and Reporting

When the Legislature is in session, we will provide weekly written updates as described in the scope of services, but more often if any proposed legislation may have an impact on Charlotte County. Reporting will include both written and verbal exchanges.

We will deliver an annual in-person and written legislative wrap-up to the Charlotte County Board of County Commissioners at the end of the legislative session summarizing all activities assumed on behalf of Charlotte County and the results of these undertakings.

Outside of session, we will continue to meet with the Charlotte County Board of County Commissioners, attend regulatory and local meetings on behalf of Charlotte County when necessary.

Management and Integration

Management and integration of the deliverables for Charlotte County will be the prime responsibility of Kari and Lucas, both adept at proficiently multi-tasking for multiple clients. Timelines for tasks will be established and weekly updates and communication between the Tallahassee and Tampa office will occur. Customized legislative tracking charts will be created for tracking bills of interest and Charlotte County's priorities. - Facilitate meetings with policymakers, legislators, and leaders of relevant state agencies to advocate for local government issues.
- Create briefing sheets, talking points, and other materials needed for meetings, and assist in the preparation of testimony before legislative committees.
- Advise when County representatives may be required in person in Tallahassee to address issues of
 particular interest to the County and prepare backup information and talking points for these sessions.
- Monitor and advocate for Charlotte County's interests before state agencies.



- Monitor state funding opportunities and coordinate with County's legislative staff.
- Aid in the development, preparation, and management of state appropriations requests.
- Deliver a comprehensive written summary of legislative activities and the impacts of approved legislation to present before the Commissioners.
- Ensure coordination with other lobbyists representing Charlotte County on policy or appropriations activities
- Conduct research and gather data to support the County's positions on environmental and water quality issues, demonstrating the County's needs and advocating for legislative attention where appropriate.
- Coordinate and facilitate meetings with local governments to identify opportunities to partner on the County's water and environmental objectives.
- Perform any other pertinent duties and actions related to state relations as required by the County.

Team

Kari Hebrank, Specific Role with Carlotte County

Kari will be responsible for monitoring legislation; securing bill sponsors and drafting amendments as determined by the Charlotte County Board of County Commissioners; meeting directly with legislators, committee staff and executive branch staff; drafting "talk sheets"; testifying before legislative committees and at agency rule hearings as appropriate; arranging meetings with legislators and agency personnel; tracking and reporting of bill progress, including periodic written reports and drafting correspondence to the executive and legislative branch on behalf of Charlotte County as required. Moreover, Kari will provide guidance on political contributions and elections based on information gathered through candidate interviews, district data and intelligence gathered from key lawmakers and colleagues. Furthermore, Kari will collaborate with the Florida Association of Counties, the Florida League of Cities, consultants for other counties, and other stakeholders. She will also be responsible for administering the contract with Charlotte County.

Lucas Parsons, Specific Role with Charlotte County
