AMENDMENT #1 TO CONTRACT NO. 2019000557 BETWEEN CHARLOTTE COUNTY

and FLORIDA PREMIER CONTRACTORS, LLC for

CONSTRUCTION MANAGER AT RISK PLACIDA BOAT RAMP WEST

THIS AMENDMENT #1 to Contract No. 2019000557 (the "Amendment") is made and entered into by and between CHARLOTTE COUNTY, a political subdivision of the State of Florida, 18500 Murdock Circle, Port Charlotte, Florida 33948-1094 (the "County"), and FLORIDA PREMIER CONTRACTORS, LLC., 25450 Airport Road, Suite A, Punta Gorda, Florida 33950 (the "Construction Manager" or "CM").

RECITALS

WHEREAS, the County and the Construction Manager entered into Contract No. 2019000557 (the "Agreement") on or about November 14, 2019, to engage the Construction Manager for preconstruction and construction services for the Placida Boat Ramp West (the "Project"); and

WHEREAS, pursuant to the terms of the Agreement, the Project is to be completed in two phases, Phase I – Pre-Construction Services, and Phase II – Construction Services; and

WHEREAS, Phase I of the Project – Pre-Construction Services – is complete; and

WHEREAS, the Guaranteed Maximum Price (GMP) for Phase II of the Project has been agreed to by the parties, and pursuant to the Agreement, the GMP shall be made a part of the Agreement by an Amendment to the Agreement; and

WHEREAS, the parties now wish to amend the Agreement to provide for the GMP for the Project, to provide for a time for completion, to provide certain additional terms and conditions and to provide for Liquidated Damages in the event the Construction Manager fails to achieve substantial completion as set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the County and the Construction Manager agree as set forth below:

ARTICLE I GUARANTEED MAXIMUM PRICE

- 1.1. The GMP Summary/Fees/Schedule of Values, Clarifications, Project Schedule and Site Logistics Plan for Phase II of the Project, submitted by Construction Manager and agreed to by the parties, is attached hereto as **Exhibit A**, GMP Summary, and is specifically incorporated into and made a part of the Agreement.
- 1.2. In accordance with the terms of the Agreement and **Exhibit A** attached, the parties agree that the Guaranteed Maximum Price for the Project shall be Three Million Three Hundred Eighty-Eight Thousand Eight Hundred Eighty-Three Dollars and no cents (\$3,388,883.00).
- 1.3. All applications for, and terms of, payment for Phase II of the Project shall be in accordance with Section 6 of the Agreement.

ARTICLE II LIQUIDATED DAMAGES

- 2.1. Pursuant to the Project Schedule, **Exhibit A**, attached, construction services shall be completed on or before September 30, 2021 (as previously established, remaining unchanged).
- 2.2. Pursuant to Article 11.4 of the Contract, Liquidated Damages are established at Five Hundred Dollars (\$500.00) per day.

ARTICLE III MISCELLANEOUS

- 3.1. The effective date of this Amendment is the date on which it is signed by both parties.
- 3.2. Any terms used in this Amendment shall have the same meanings and definitions as they have in the Agreement.
- 3.3. All other provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
