Re: Charlotte County Utilities Burnt Store Water Reclamation Facility Expansion Bid No. 202400202 Bid Evaluation and Recommendation

Dear Ms. Corbett and Mr. Bullert:

McKim & Creed is tasked with assisting with the bid evaluation, reviewing the certified tabulation of bids prepared by Charlotte County, reviewing the references of the apparent responsive and responsible low bidder, and preparing this bid evaluation and recommendation for the County's use, in relation to the referenced project. This letter summarizes our bid evaluation and recommendation of the construction contract low bidder received for the Charlotte County Utilities - **Burnt Store Water Reclamation Facility Expansion - Bid No. 202400202,** advertised on December 22, 2023.

Two (2) bids were submitted on Wednesday, April 17, 2024 at 2:00 PM. The apparent low bidder, Thalle Construction Co., Inc. submitted a bid with a total bid amount of \$171,799,950.00, and the second bidder, Poole & Kent Company of Florida submitted a bid with a total bid amount of \$178,922,100.00. The bids received are within approximately 4% of each other.

McKim & Creed Inc. reviewed the bid received from the apparent low bidder, Thalle Construction Co., Inc. and report the following findings:

239.275.8875The Bid Bond (5% of the total bid amount) was provided, and the Bid Bond surety isFax 239.275.7029licensed in Florida. Submittals were signed, and all items on the checklist were submitted.

www.mckimcreed.com Thalle Construction Co., Inc. is not a federally debarred contractor.

The bid documents required the Contractor to submit reference information for a minimum of three (3) recent (within the past five years) projects of similar size and scope. Only one of the three reference projects identified by Thalle Construction Co., Inc., City of Round Rock (Brushy Creek Wastewater System East Plant Expansion to 30 MGD), was determined to be of similar size and scope. The two other reference projects identified by Thalle, Trinity River Authority (CWRS Regional wastewater System Phase IIIB Filter Improvements) and Orlando Utilities Commission (OUC SEC Lined Pond) were determined to not be of similar scope and size. Further, the contact information for all three reference projects was incorrect and/or outdated. The owner's representative of the Round Rock, Texas project indicated that the project is not completed and is currently 429 days past the contractual substantial completion date. This is contrary to the reference information provided by Thalle Construction Co., Inc. in their bid, which states that the project was completed on 2/13/2023.

McKim & Creed requested a Dun & Bradstreet (D&B) Business Information Report on Thalle Construction Co. Inc.. See Exhibit 2. Based on the report, Thalle Construction Co., Inc. has an overall D&B business risk rating of moderate to high risk. Per D&B, Thalle Construction Co., Inc. has significant stability concerns, a higher than average risk of financial stress, discontinued operations or discontinued activity, and a moderate potential for severely delinquent payments.

Based on the information provided by Thalle Construction Company, Inc., McKim & Creed recommends that the County consider the Thalle Construction Co., Inc bid as nonresponsive, due to their failure to provide three reference projects of similar size and scope, and their failure to accurately report the completion date of one of their reference projects. McKim & Creed also recommends that the County consider the potential business risk associated with awarding this size of a project to Thalle Construction Company, Inc. in light of the results of the Dun and Bradstreet Report.






