Support Services

Charlotte County Habitat for Humanity provides families with a mentoring program along with homeownership and personal budgeting classes. The Punta Gorda Housing Authority links clients with support services available within Charlotte County. The Gulf Coast Partnership (CoC) was awarded County funding to develop an Economic Resiliency program that includes HUD-certified Housing Counseling, homebuyer education, financial literacy programming, etc., that is available to SHIP recipients.

Other Accomplishments

The first Charlotte HOME affordable rental property, subsidized with local Affordable Housing Trust Fund (AHTF) subsidy, SHIP multi-family construction funds, City of Punta Gorda LGAO contribution, and a BCC gap loan, was added to inventory (in conjunction with FHFC RFA 2022-201).

The Annual Report is published 1 week prior to and presented to the Charlotte County Affordable Housing Advisory Committee (AHAC) and Board of County Commissioners (BOCC) for certification at their regular public meetings prior to the annual report deadline.
