A. Qualifications

1. Letter of Interest Summarizing Proposers Qualifications

1596 Strategic Response Solutions, LLC (1596 SRS) understands the County of Charlotte is seeking qualified offerors capable of providing medical support staffing services in shelters or disaster sites in compliance with Federal Emergency Management Agency (FEMA), State of Florida, and local standards. 1596 SRS is a Small Business Administration (SBA)-approved Mentor-Protégé Joint Venture (JV) formed between Cotton Commercial USA, Inc. (Cotton), the Mentor / JV member, and Vision Quest Solutions, Inc. (VQS), the Protégé / JV managing venturer. This is an unpopulated JV, meaning it does not directly employ personnel to perform contract work. Instead, all work is performed by the employees of the JV member companies—Cotton and VQS—under the terms of the JV agreement. This structure allows 1596 to leverage the combined experience and financial strengths of both firms. Each entity offers the following capabilities to Charlotte County:

C. Approach

1. Project Approach

1596 SRS's project approach is grounded in rapid response capability, rigorous credentialing standards, and proven success in emergency medical staffing. We combine operational knowledge gained through over two decades of FEMA deployments with our Joint Venture's Joint Commissioncertified healthcare staffing systems to ensure full compliance, swift mobilization, and seamless integration with County operations. Our strategy emphasizes readiness, flexibility, and the delivery of high-quality care in pre-, ongoing, and post-disaster environments.

Recruiting and Retention

1596 SRS is an experienced and proven provider of medical staffing and disaster response services, with nationwide experience placing Medical Directors, RNs, Physician Assistants, EMTs, Paramedics, and more. Our approach to staffing shelters begins with targeted, proactive recruitment. 1596 SRS already initiated recruitment efforts specific to this contract to ensure a pool of qualified, licensed professionals is readily available to meet dynamic and evolving requirements. Since posting the medical staffing positions across job boards, we have obtained over 90 qualified resumes to include bilingual candidates. Our recruiting and credentialing teams have pre-vetted all resumes to verify compliance with qualifications.

We leverage a multi-layered, systemic recruitment process that combines the expertise of our inhouse medical recruiting team with industry-leading talent sourcing tools and platforms. - Jobbing Sites With access to over 40,000 medical professionals, our team follows a specific vetting process to match, recruit and retain qualified staff. 1596 SRS has a strong online presence with targeted advertisements on national and state-specific healthcare job boards, including MD Jobsite, PracticeLink, Florida Health Careers, the Florida Medical Association Job Board, and regionally through platforms such as Lee Health Careers and geo-targeted postings on Indeed and LinkedIn.
- Geo Targeting While 1596 SRS has a strong online presence, our recruitment efforts extend beyond standard job placement boards. Our recruitment specialists also use a Geo Targeting platform to create email and web campaigns that target specific geographic areas or provider skills based on disaster shelter needs. Geo Targeting recruiting is a form of location-based recruitment where a geographic boundary is placed around a point of interest. When a mobile device enters this area, the geofence can trigger several different events. These triggers are usually the delivery of advertising on a chosen platform, such as internet ads or digital billboards.
- Local and National Recruiting Frequently our recruiting specialists attend local and national medical/healthcare professional conferences, job fairs and meetings targeted towards health care professionals. Each contact met at these events is entered into our TMS with detailed notes.
- Education Partnerships 1596 SRS partners with local nursing schools, community colleges, and vocational training centers to engage newly licensed RNs and CNAs seeking hands-on experience in disaster response and shelter operations. We also participate in healthcare job fairs and host recruitment events to attract qualified personnel.




Figure 1. xxx.

Step 3 entails a pre-screening interview to verify candidate credentials. Although our recruiting platforms and medical recruiters excel at filtering candidates with accurate credentials and experience, the prescreening interview remains a critical component of the initial verification process. During the prescreening interview, the following criteria are discussed and assessed:

COMPENSATION

- What is the candidate's compensation expectation?
- Is this request reasonable given experience, credentials, position expectation, location, etc.? Is the candidate comfortable proceeding with the identified compensation range?

AVAILABILITY

 What is the candidate's minimum availability? Are they able to deploy quickly and be on location within 48 hours of notice?

LOCATION

- · Is the candidate able to commute directly to the work location?
- Would the candidate require temporary lodging?
- · Have they experienced the geographical area to which they are applying?

• Can the candidate provide at least two clinical references with whom the health care professional reported to in a similar healthcare environment?

pipeline. We also ensure a mix of female and male medical staff to accommodate resident preferences, particularly within the Mental Health Provider labor category. As an added value to Charlotte County, our pipeline for the medical support staffing services for disaster shelters includes additional labor categories. This enables 1596 SRS to provide support, regardless of the type of disaster. Additional labor categories in our pipeline include Emergency Medical Technicians and Paramedics.

By maintaining a pool of pre-screened, credentialed candidates, we ensure swift deployment of qualified medical personnel to meet emergency needs and fulfill contract requirements. This readiness is complemented by our comprehensive onboarding and orientation processes, which prepare staff for the challenges of working in unpredictable environments.

To further enhance the effectiveness of deployments, we foster strong lines of communication with local authorities and emergency management teams. This collaboration ensures that our staff integrates seamlessly into existing response structures, enabling efficient, synchronized operations in times of crisis.

Training

1596 SRS ensures that all medical personnel deployed to shelter operations are highly trained, properly credentialed, and prepared to operate in austere, high-pressure post-disaster environments. Our training program is specifically tailored to the responsibilities of healthcare professionals serving in general population and special needs shelters and follows guidance set forth in FEMA's Shelter Field Guide (FEMA P-785) and Florida's 2024 Statewide Emergency Shelter Plan (SESP).

Medical staff are trained to fulfill the shelter roles outlined in FEMA P-785 under Health Services and Mental Health Services, including support for individuals with access and functional needs (AFN), triage, ongoing patient monitoring, documentation, and coordination with local emergency management and public health.

Key training elements include:

Shelter-Based Medical Operations:

- o Role of medical staff in shelter triage and health surveillance
- Infection prevention, isolation protocols, and chronic condition management
- Documentation and information sharing in compliance with HIPAA and emergency protocols
- o Emergency referral procedures for shelter residents requiring acute care

Access and Functional Needs (AFN) Support:

- Awareness training on physical, cognitive, sensory, and behavioral disabilities
- o Guidelines on care for clients using durable medical equipment (DME), oxygen, and other assistive devices
- Familiarity with ADA and Section 504 requirements for equitable access to care

Public Health Emergency Readiness:

Enhanced training on infectious disease mitigation, PPE usage, and screening protocols


1596 SRS aligns medical support activities with Florida's shelter designations, ensuring our personnel are trained and capable of serving within both General Population Shelters and Special Needs Shelters, as defined under Section 381.0303(2)(d), F.S.

Staff and Operate Shelters for Medically Dependent People

1596 SRS brings the experience, infrastructure, and staffing readiness required to staff and operate shelters for medically dependent individuals in Charlotte County. Our operations are built on a foundation of FEMA-compliant protocols, pre-positioned assets, and medical leadership with firsthand experience in shelter command and control.

Shelter Operations Management. 1596 SRS assumes full operational responsibility for the medical staffing pre-,during, and post disaster at shelters for medically dependent people. This includes:

- Establishing functional care zones (triage, observation, isolation, medication administration) if not pre-established
- Integrating with County Emergency Management, local EMS, and shelter site security to ensure a unified command structure
- Maintaining a chain of command and 24/7 supervisory presence onsite
- Working closely with the medically dependent patient, family, and caregivers to meet medical needs and provide care

Medical Care and Staffing. Our team of licensed medical professionals ensures continuity of care by:

Training and Credentialing. All personnel are pre-vetted, credentialed, and trained in:

- All training elements listed in the Training Section

All medical staff will be easily identifiable through uniformed scrubs and identification badges. We require all medical staff to maintain patient charts and complete reporting. All documentation is stored in accordance with HIPAA.

Integrate and Collaborate with Shelter General Support Team

1596 SRS is fully committed to seamless integration with the Shelter General Support Team (GST) in Charlotte County to ensure unified, efficient shelter operations. We understand that collaboration across logistics, medical, and administrative functions is essential to the health and safety of shelter residents. Our leadership team and Medical Managers possess decades of experience working alongside multi-disciplinary teams in emergency response environments, including coordination with logistics, operations, public health, and emergency management personnel at the local, state, and federal levels.

Our Lead Medical Manager will be physically present and assigned to a central shelter location in Charlotte County. They will serve as the primary point of contact for the County and GST. The Lead Medical Manager brings deep operational leadership, clinical oversight, and disaster response experience, and will work closely with GST leads to aligning medical services with broader shelter support operations. This includes coordination on shelter layout, logistics, medical supply requests, and operational briefings, all while ensuring full compliance with County, FEMA, and HIPAA regulations.

To enhance coordination at the shelter level, 1596 SRS also designates secondary points of contact at each shelter. These Medical Managers report directly to the Lead Medical Manager and are responsible for day-to-day integration with the Shelter GST, ensuring clear communication, responsive issue resolution, and consistent alignment across all shelters.

This depth of experience—paired with an established leadership presence on the ground and a history of effective multi-agency collaboration—ensures that 1596 SRS will deliver high-quality, mission-ready medical support from day one.


1596 SRS is fully prepared to deploy personnel with a self-contained, 72-hour supply of meals and water. Each staff member will arrive with:

- Nine pre-prepared meals (3 breakfasts, 3 lunches, 3 dinners) catered by our in-house Culinary Team, designed to be nutritious, energy-sustaining, and shelf-stable for field conditions.
- One case of bottled water per staff member, consisting of 24 bottles (16.9 fl oz each) of spring or fresh water.

In environments where resupply is permitted, additional fresh food deliveries can be scheduled for at least the subsequent 48 hours. In scenarios where the shelter area is closed to resupply, 1596 SRS maintains a stock of long shelf-life, pre-packaged meals comparable to military-style MREs. These are ready for deployment to ensure uninterrupted sustenance for the full 72-hour operational window.

Communicate and coordinate directly with Charlotte County Mass Care, Office of Emergency Management, or delegated appointee.

1596 SRS is well-positioned to maintain direct and effective communication with Charlotte County Mass Care, the Office of Emergency Management, and any delegated appointees. Drawing from our extensive experience supporting FEMA and operating in disaster environments, we understand the importance of real-time coordination, accurate information sharing, and alignment with local emergency protocols.

Upon award, we will immediately provide contact information for our Lead Medical Manager and Medical Managers and facilitate introductions to designated County representatives. 1596 SRS's CNO will be the primary point of contact, lead incident commander, and is ultimately responsible for day-to-day interface with the County. Our Medical Managers, reporting directly to our CNO, will serve as the secondary liaisons ensuring seamless operational integration and uninterrupted care delivery.

To support coordinated response efforts, 1596 SRS will:

- Establish 24/7 lines of communication with Charlotte County Mass Care, Emergency Management, and appointed liaisons
- Provide timely status updates and operational briefings
- Maintain open, responsive communication to support rapid decision-making and continuity of care




Figure 4. Lines of Communication. Centralized communication flow with the Lead Medical Manager serving as the primary point of contact to the County and directing all operational updates to Medical Managers across shelters.

Figure 4 depicts the command structure and lines of communication between 1596 SRS's leadership and the County. Providing the County with a primary point of contact:

- Reduces confusion by centralizing all updates, decisions, and requests through one knowledgeable liaison
- Enables rapid coordination with County officials, shelter managers, and clinical teams
- Maintains consistent situational awareness and ensures shift-to-shift handoffs don't disrupt operations
- Offers the County a reliable, empowered individual who owns the execution of the contract
- Builds trust between the County and contractor through face-to-face interaction and familiarity

Medical teams must be prepared to provide on-demand services in a shelter environment before, during, and after an event.

1596 SRS takes a proactive approach to preparing our medical teams for deployment in shelter environments across all phases of an emergency response—before, during, and after an event. Prior to deployment, we ensure our medical personnel are fully credentialed, briefed on local hazard profiles, and properly equipped. Our Lead Medical Manager with assistance from our CNO/Medical Manager provides training prior to operations start to ensure rapid familiarization with State of Florida shelter-specific protocols, including infection control, triage procedures, documentation systems, and communication lines with incident command. The training includes protocols for special needs shelters, and all medical staff are cross-trained to ensure they can be assigned to any shelter type. By requiring 100% of our medical staff to be capable of providing care across all shelter environments, 1596 SRS enhances the consistency and quality of care delivered during a disaster—while maintaining a focus on patient-centered outcomes.

During the event, our teams operate with high autonomy, supported by 24/7 clinical oversight and logistics coordination. They perform real-time assessments, administer acute care, and address

both chronic and emergent conditions under resource-constrained conditions. We prioritize continuity of care, data capture, and adaptability as the population's needs evolve.

After the event, our personnel participate in post-event health monitoring, patient transition support, and demobilization protocols. We conduct after-action reviews (AARs) and integrate findings into future readiness planning. This cycle of continuous improvement ensures 1596 SRS medical teams remain capable of delivering high-quality, responsive care in shelter environments.

Provide team level activity log (FEMA ICS Form 214 or approved equivalent) at the end of each shift to the County

During initial mobilization, 1596 SRS's Lead Medical Manager with assistance from our CNO/Medical Manager provides an orientation to all medical staff deployed for the service request. Mr. Amador covers all reporting and record keeping compliance and provides instructions on completing FEMA ICS Form 214. This provides standardization across FEMA ICS Form 124 completion regardless of which shift Medical Manager is completing the team activity log. Enabling the County of Charlotte to receive the necessary information upon submission while reducing potential requests for clarification. 159S SRS will provide the forms electronically or in printed form, depending on the County's preference.

2. Schedule/Timeline

1596 SRS has the resources, assets, and infrastructure to successfully mobilize service requests and complete deployments within 48 hours. Our CNO/Medical Manager and Chief of Fire are based out of central Florida, within three hours of Charlotte County. This enables leadership to quickly respond to disasters and be onsite to coordinate with arriving medical staff, check-in as a complete unit, and begin operations within 12 hours of check-in. 1596 SRS prides itself on responsiveness and flexibility to ensure customer satisfaction. The table below provides a graphical representation of our proposed mobilization schedule/timeline. While we propose the schedule below, we can adjust the timeframe of any major milestone and/or deliverable to align with Charlotte County's preferred delivery window upon award or service request.

3. Organization

To meet the County's requirement for qualified clinical leadership within each shelter, 1596 SRS will deploy a Lead Medical Manager with a Medical Doctor, Advanced Practice Registered Nurse, or Physician's Assistance License as well as Medical Managers, each of whom will be a licensed Registered Nurse (RN) in good standing with current and active licensure. In accordance with the solicitation, the Lead Medical Manager will be directly responsible for:

- Supervise all Medical Managers across activated shelters, ensuring continuity and standardization of care
- Serve as the clinical operations lead and escalation point for all on-site medical matters
- Provide real-time guidance and decision-making during complex or evolving clinical scenarios
- Ensure cross-shelter alignment with FEMA, County, and State protocols
- Conduct quality assurance checks, staff coaching, and operational debriefs
- Represent the medical mission at County-level coordination meetings and operational briefings

Our Medical Managers will be directly responsible for:

- Planning, coordinating, and executing medical operations in support of shelter services
- Providing leadership in clinical decision-making, patient triage, chronic disease management, and infection control
- Maintaining staff supervision and shift coverage for RNs, EMTs, paramedics, and allied health professionals
- Ensuring compliance with public health guidance and implementation of medical surge strategies
- Coordinating with multi-agency partners and serving as the primary point of contact for medical services within the shelter
- Overseeing documentation, care escalation protocols, and real-time problem-solving in dynamic environments




Figure 5. Medical staffing structure for Charlotte County shelters, showing 24/7 Medical Manager oversight under the on-site Chief Nursing Officer, supported by clinical and mental health teams across all shelter types.

The organizational chart (Figure 5) on the next page details the hierarchy of our proposed staffing plan as well as corporate reach back and the lines of communication between 1596 SRS assets and the County. The diagram illustrates the tiered deployment of clinical personnel across Special Needs and General Population shelters, with direct oversight from the on-site Chief Nursing Officer. Medical Managers lead 24/7 operations at each shelter, supported by nurses, CNAs, and mental health providers to ensure safe, continuous care aligned with County coordination.

D. Cost Proposal

1596 SRS provides labor rates and other direct pricing in the tables below. All pricing is valid for 120 days from the submittal deadline. Equipment pricing may be structured using an à la carte model if preferred by Charlotte County.

Assumptions

The proposal assumes that medical supplies and equipment will be stocked in quantities sufficient to support the shelter's initial population and potential surges. This includes critical supplies like PPE, trauma care materials, and diagnostic equipment, with backup stock and real-time inventory tracking to ensure timely resupply. Vendor agreements will allow for rapid restocking of essential items, with flexible contract terms to accommodate increasing shelter populations. The supply system will also be scalable, with provisions for adjusting quantities based on real-time shelter assessments and needs, ensuring that high-demand items are replenished quickly.

After the disaster response, a comprehensive inventory evaluation will be conducted to analyze usage rates and identify gaps in supply. Feedback from medical staff will guide adjustments to future procurement strategies, optimizing stock quantities and types. The evaluation will also address expired or underutilized supplies, ensuring that future contracts focus on essential items and prevent overstocking of perishable goods. This post-emergency review will inform better preparedness for future events, ensuring that the medical supply system is both efficient and responsive.

Additional assumptions include:

- Pricing is based solely on the scope of services provided in this proposal.
- Any items not expressly outlined in 1596 SRS's response are excluded from the scope of services. A comprehensive list of included equipment is provided in the section below.
- Pricing assumes that an operational shelter clinic will be identified and established within 12 hours of a formal Notice to Proceed.
- All pricing excludes Federal, State, and Local taxes.
- Labor rates are subject to a 3% escalation after the base period.
- If medications beyond those included in the medical bag are required, 1596 SRS will provide them at an additional cost, subject to availability and approval.
