Dear Commissioner Tiseo,

I am respectfully requesting the Board's approval for Fiscal Year 25/26 budget amendment as follows:

We had to suspend the rebuilding of our UH-1H (Huey) during mosquito spraying season. The funds for the overhaul were requested during Fiscal Year 24/25, and the portion that was not used due to the suspension of the repairs was returned to the Board as part of fiscal year-end excess fees. We are respectfully requesting \$984,500 back to complete this overhaul during this current fiscal year.
