#### AMENDMENT #1 TO CONTRACT NO. 2023000154 BETWEEN CHARLOTTE COUNTY

# AND KCI TECHNOLOGIES, INC.

### FOR REPAIR OR REPLACE ROTONDA MSBU BRIDGE 014113

**THIS AMENDMENT #1** to Contract No. 2023000154 is made by and between CHARLOTTE COUNTY, a political subdivision of the State of Florida, 18500 Murdock Circle, Port Charlotte, Florida 33948-1094 (hereinafter the "County") and KCI TECHNOLOGIES, INC., 4041 Crescent Park Drive, Tampa, Florida 33578 (hereinafter the "Consultant").

**WHEREAS,** on or about June 12, 2023, the parties entered into Contract No. 2023000154 (the "Contract"), to provide professional services to determine the most cost-effective solution to restore/rehabilitate/replace a 3-span prestressed concrete slab bridge severely impacted by Hurricane Ian (the "Project"); and

WHEREAS, the County desires to add additional Project Services; and

**WHEREAS**, the Consultant has been providing, and is capable of continuing to provide, the necessary Project services.

**NOW, THEREFORE**, in consideration of the mutual terms and conditions, promises, covenants and payment hereinafter set forth, County and Consultant agree to amend the Contract as follows.

## ARTICLE I COMPENSATION / SERVICES

- 1.1. The following provisions of this Amendment, and **Exhibit A,** Scope of Services, attached hereto, are specifically incorporated into and made a part of the Contract.
- 1.2. The Scope of Services for the Project is hereby amended to add Task 15, as described in **Exhibit A**, and this Amendment.
- 1.3. The County shall pay Consultant for these services an amount not to exceed Thirty Thousand Dollars and no cents (\$30,000.00), as described in **Exhibit A**, attached.
- 1.4. Payment for services rendered on Task 15 shall be made monthly based on the number of hours spent and the hourly rates specified in **Exhibit A**. Billings shall be detailed as to the nature of the tasks performed, the Associate performing the task, the number of hours spent on each task and the hourly rate(s) applicable.
- 1.5. The addition of Task 15 services will not affect the timeline for performance of the Contract.

## ARTICLE II MISCELLANEOUS

2.1. The effective date of this Amendment is the date on which it is signed by both parties.

- 2.2. Any terms used in this Amendment shall have the same meanings and definitions as they have in the Contract.
- 2.3. All other provisions of the Contract not in conflict with this Amendment shall remain in full force and effect.
