**A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA,
TO ADOPT A NEW SCHEDULE AND PROCEDURE FOR
ADOPTION OF CHARLOTTE COUNTY UTILITIES RATES,
FEES, AND CHARGES; AND TO PROVIDE AN EFFECTIVE
DATE.**

RECITALS

WHEREAS, on July 22, 2025, the Board of County Commissioners of Charlotte County, Florida ("Board") adopted Resolution No. 2025-241, establishing a Schedule fixing water, sewer, and reclaimed water rates, fees, and charges for the utility services to present and future customers of Charlotte County Utilities ("CCU"); and

WHEREAS, on January 13, 2026, the Board held a public meeting whereby all the owners, tenants, and occupants of property serviced or to be serviced by CCU and all other interested parties had an opportunity to be heard concerning proposed changes in CCU rated, fees, and charges, notice of which public meeting was properly and timely published in a newspaper published in Charlotte County; and

WHEREAS, on the advice and recommendation of its technical advisors, and after hearing from the public, the Board has determined the new water, sewer, and reclaimed water rates are just and equitable, and in the public interest.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Charlotte County, Florida that:

1. The Charlotte County Utilities Rate Schedules for Water, Sewer, and Reclaimed Water, attached and incorporated collectively herein as "Exhibit A", are hereby adopted to be effective for utility bills on or after April 1, 2026, and are effective until

automatically adjusted pursuant to the index provision below or such time that the Board adopts new schedules of rates, fees, and charges for the services.

2. The Rates, Fees, and Charges (Schedule A) for the Charlotte County Utilities Uniform Extension Standards, attached and incorporated herein as "Exhibit B", is hereby adopted.

3. The Miscellaneous Fees and Charges (Schedule C), attached and incorporated herein as "Exhibit C", is hereby adopted.

4. Beginning on October 1, 2027, the rates, fees, and charges adopted in Paragraph 1, 2, and 3 shall automatically increase annually as of the first day of the fiscal year, without hearing, by 3.5% or by the index adopted by the Florida Public Service Commission pursuant to Section 367.081(4)(a), Florida Statutes, whichever amount is greater.

5. This Resolution shall be effective upon adoption.
