Richard Arthur, Fiscal Services Manager introduced Murray Hamilton, Raftelis Vice President, gave a brief overview of Recommendations, Next Steps, replied to connection fee analysis, timeframe, flexibility, timing, and

Mr. Hamilton gave a brief overview of Project Milestones, Financial Scenarios Considered, Proposed Water Connection Fees, Proposed Wastewater Connection Fees, Comparison of Capacity Costs, Comparisons of Capital Planning Scenarios, Projected Rate Adjustments - Fiscal Year (FY) 2026 - 2030, Projected Rate Adjustments - FY

2031 - 2035, Can Charlotte County Utilities (CCU) establish different connection fees by benefit zones, What are the pros and cons of creating connection fee zones: Pros, Cons, Can CCU establish different monthly service rates

for existing and future customers, responded to bond reserve policies, revenue sufficiency studies, capital

planning element changes, and incremental adjustments.

Chair Tiseo discussed new development and monthly bill impacts, cost responsibility, connection fees, 3 million gallons per day (MGD), existing and new rate payers, improvement costs and benefits, plant expansions, housing market, Next Steps, and date flexibility. Commissioner Constance mentioned Financial Scenarios Considered, inflationary factors, Proposed Water Connection Fees, Projected Rate Adjustments - FY 2026 - 2030, Projected Rate Adjustments - FY 2031 - 2035, Comparisons of Capital Planning Scenarios, savings, water and wastewater rate indexing versus independent indexing, Peace River Manasota Regional Water Supply Authority (PRMRWSA) service areas, Babcock Ranch, Burnt Store, bond issuance, Can CCU establish different connection fees by benefit zones, East Port, Can Equivalent Residential Unit (ERU), current rate payers, expansion cost responsibility, resiliency, capacity, operations and maintenance (O&M), and Recommendations. Commissioner Deutsch commented on regional water bill and future development impacts, cost savings, infrastructure, capacity, and Cons. Commissioner Doherty spoke to Proposed Water Connection Fees, Proposed Wastewater Connection Fees, May 22, 2025 Utilities Department Quarterly Update Meeting, water treatment and water reclamation facilities, plant expansions, 3 MGD, bond issuance financing, advanced wastewater treatment (AWT), repair and replacement (R&R), indexing methodology, Capital Improvement Projects (CIP) analysis, Comparisons of Capital Planning Scenarios, Can CCU establish different connection fees by benefit zones, Can CCU establish different monthly service rates for existing and future customers, Impact Fees, East Port, October 7, 2025 Utilities Department Quarterly Update Meeting, Recommendations, July 15, 2025 Utilities Department Quarterly Update, flexibility, Next Steps, June 24, 2025 Regular Meeting, and delay impacts. Commissioner Truex noted utility impacts, Projected Rate Adjustments - FY 2026 - 2030, Projected Rate Adjustments - FY 2031 - 2035, debt service savings, May 22, 2025 Utilities Department Quarterly Update Meeting, Rate Resolution, and Recommendations.

County Attorney Knowlton interjected on timing, Rate Resolution, and flexibility.

County Administrator Flores replied to July 15, and October 7, 2025 Utilities Department Quarterly Update Meetings.

County Administrator Flores discussed Construction Manager at Risk (CMAR) - Burnt Store Water Reclamation Facility (WRF).

Dave Watson, Utilities Director remarked on Burnt Store WRF, CMAR contract, July 15, 2025 Utilities Department Quarterly Update, Kimley-Horn, Florida Department of Environmental Protection (FDEP) permit modification, estimated construction cost, capacity, connection fees, package plant option, and timeframe.

Chair Tiseo mentioned regulatory agencies, construction time schedules, capacity, compliance, package plant option, and June 18, 2025 PRMRWSA 3C Regional Interconnect Valve Turning Ceremony. **Commissioner Doherty** commented on package plant option.
