### Request:

The applicant, George R. Roland, is requesting to vacate a portion of Barcelona Court adjacent to 400 Seminole Road, being his property and described as Lots 8 through 17, Block 194, of Harbour Heights Section Thirteen, as shown on Plat Book 5, Pages 32A through 32B, of the Public Records of Charlotte County, Florida. The total area to be vacated contains 6,089± square feet or 0.14± acres (See Attachment 1) and is generally located north of Deep Creek Boulevard, southwest of the Peace River, and east of Seminole Road, within the Punta Gorda area and located in Commission District I.

### Analysis:

The subject area to be vacated lies outside the Urban Service Area. The underlying Future Land Use Map (FLUM) designation is Low Density Residential. The underlying Zoning District is Environmentally sensitive (ES). It lies within Flood Zone 10AE and Storm Surge Evacuation Zone A.

If approved, the petition would allow more developable space on the property. No residents will be denied reasonable access to their property as a result of this petition. All pertinent departments have reviewed the petition (See Attachment 2). All the affected utilities have been notified. County staff have offered no objections.

### Current Status:

This petition was continued before the scheduled presentation to the Board in August 2023 due to comments regarding the encroachments into the platted Barcelona Canal. Since then, the applicant has resolved all staff comments pertaining to those encroachments and staff have no further comments.



**Staff Summary:**

Based upon the analysis and conclusions set forth herein, in staff's professional opinion, the application (Application #**SV-23-03-01**) is generally consistent with Charlotte County's Comprehensive Plan, Charlotte County's Code of Laws and Ordinances and other applicable guidelines.

**Planning and Zoning Board proposed recommendation on July 10, 2023:**

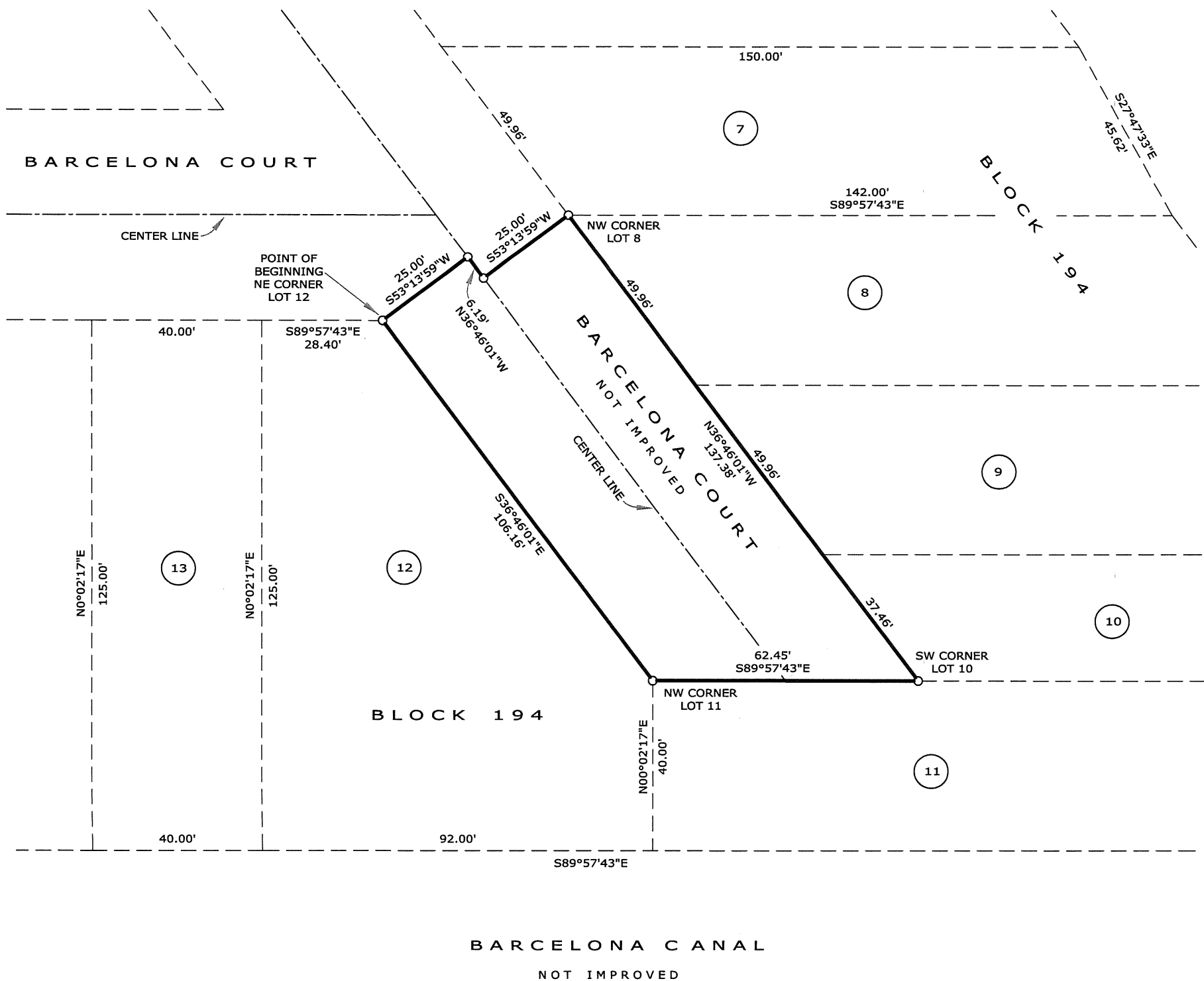
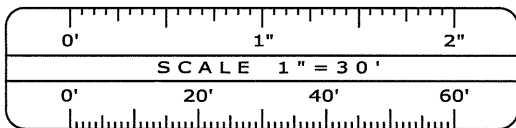

Joanne, exactly one year ago, Jenny Shao asked for comment from your department concerning a Plat vacation, PV-23-09-08, PW suggested a couple items.

1. We should consolidate all of our lots into one parcel, which we did May 2024.
2. We officially rescinded the request to vacate the Barcelona Canal, realizing it would not be approved.
3. We received and recorded two agreements, one consent to encroach on county easement and another to encroach on county canal ROW.
4. We were asked to get a ROW clearing and construction agreement with the county and we did.
5. We were asked to get a permit to “relocate driveway to ROW, and we did. Permit 20240729835.
6. The driveway was extended and a final inspection was done, 11/14/24. I was not notified of the results, and I called the PW, a representative told me the inspection was approved, but we are to remove the gate pillar that is on county property, and I agreed.
