A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA, IN SUPPORT OF AND APPROVING AN ECONOMIC DEVELOPMENT INCENTIVE TO LATITUDE TOURNAMENT BOATS & ATTITUDE AIRBOATS INC.; PROVIDING FOR AUTHORIZATION TO EXECUTE AN ECONOMIC DEVELOPMENT INCENTIVE PROGRAM AGREEMENT; APPROVING A BUDGET ALLOCATION TO FUND THE ECONOMIC DEVELOPMENT INCENTIVE; AND PROVIDING FOR AN EFFECTIVE DATE.

RECITALS

WHEREAS, Latitude Tournament Boats & Attitude Airboats, Inc. ("Latitude") is a manufacturer and distributor of fiberglass boats; and

WHEREAS, Latitude is relocating its operations to Charlotte County; and

WHEREAS, Latitude has submitted a acomplete and properly executed application to the director of the economic development office; and

WHEREAS, Latitude will produce <u>1521</u> quality jobs with salaries equal to or greater than the Charlotte County Average Annual Wage (CCAW); and

WHEREAS, Latitude sales plan meets the fifty-one (51) percent export sales requirement; and

WHEREAS, Latitude is a targeted industry, and

WHEREAS, Latitude has proffered an Economic Development Incentive Program Agreement to the County, and

WHEREAS, Latitude shows a greater than one hundred (100) percent, ten-year cumulative direct return on investment, and

WHEREAS, Latitude immediately plans to construct manufacturing facility with a total capital investment of no less than \$1,450,000; and

WHEREAS, Latitude's proposal qualifies for Economic Development Incentives pursuant to Chapter 1-7, Article V of the Code and therefore constitutes a public purpose under the Code.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Charlotte County, Florida that:

- 1. The Board hereby authorizes the Chairman to execute Latitude's Economic Development Incentive Program Agreement attached as Exhibit "A."
- 2. The Board approves funding of the Employment Incentive in an amount not to exceed \$1521,000.00.
- 3. The Board approves a Capital Incentive in an amount not to exceed \$20,000.00.
 - 4. This resolution takes effect immediately upon adoption.
