## R E S O L U T I O N NUMBER 2020-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA DECLARING CERTAIN REAL PROPERTY OWNED BY CHARLOTTE COUNTY TO BE SURPLUS TO COUNTY NEEDS AND AUTHORIZING COUNTY STAFF TO DISPOSE OF SAID PROPERTY IN ACCORDANCE WITH THE PROVISIONS OF CHAPTER 125, FLORIDA STATUTES.

## RECITALS

WHEREAS, Charlotte County is the owner of real property described in Exhibit "A," attached hereto and by this reference incorporated herein (the "Property"); and

WHEREAS, the Board of County Commissioners of Charlotte County, Florida, (the "Board") is expressly authorized by Chapter 125, Florida Statutes to dispose of real property belonging to the County whenever the Board determines that it is in the best interest of the County to do so; and

WHEREAS, County staff has reviewed the real property described in Exhibit "A" and recommends to the Board that the Property be declared surplus to County needs.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, of Charlotte County, Florida:

1. The Board declares the property described in Exhibit "A" to be surplus to County needs.

2. The Board authorizes County staff to dispose of the property in accordance with Section 125.35, Florida Statutes.

3. The Board of County Commissioners authorizes the Real Estate Services Manager or his designee or the County Attorney or her designee to bid out the properties for sale and, upon bid award by the Board of County Commissioners of Charlotte County, Florida, execute the necessary documents and close the sale.

4. The Board of County Commissioners of Charlotte County, Florida hereby authorizes the Real Estate Services Manager or his designee to execute the County Deed for all surplus property bids approved for acceptance by the Board of County Commissioners of Charlotte County, Florida.

5. This Resolution shall take effect upon approval by the Board of County Commissioners.
