RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CHARLOTTE COUNTY, FLORIDA, APPROVING A PETITION FOR A TRANSFER OF TWO DENSITY UNITS IN ACCORDANCE WITH PART III. LAND DÉVELOPMENT AND GROWTH MANAGEMENT, CHAPTER ZONING, ARTICLE V, **ENVIRONMENTAL** REQUIREMENTS AND OTHER REQUIREMENTS, SECTION 3-9-150, TRANSFER OF DENSITY UNITS (TDU), OF THE CODE OF LAWS AND ORDINANCES OF CHARLOTTE COUNTY, FLORIDA; PETITION TDU-20-04; APPLICANTS, CASA SAND, LLC, LAKE HURST HOLDINGS, LLC, AND SAN CASA INVESTMENTS, LLC; PROVIDING AN EFFECTIVE DATE.

RECITALS

WHEREAS, Part III, Land Development and Growth Management, Chapter 3-9, Zoning, Article V, Environmental Requirements and Other Requirements, Section 3-9-150, Transfer of Density Units (TDU), of the Code of Laws and Ordinances of Charlotte County, Florida (hereinafter "TDU Code"), establishes processes and requirements for approval of petitions for transfers of density units in connection with petitions for rezonings and for amendments to the Future Land Use Map of the County's Comprehensive Plan, the approval of which would increase density on the subject property; and

WHEREAS, on September 8, 2020, the Board of County Commissioners of Charlotte County, Florida ("Board") approved Petition PAL-20-00003 submitted by Casa Sand, LLC, Lake Hurst Holdings, LLC, and San Casa Investments, LLC ("Applicants"), amending the Charlotte County Future Land Use Map to add an annotation limiting the overall density to five units; and

WHEREAS, pursuant to Section 3-9-150(g)(4)b.i. of the TDU Code, if a plan amendment does not involve a Planned Development rezoning, an applicant shall simultaneously submit a TDU application for a transfer of density to a Receiving Zone ("RZ"); and

WHEREAS, Applicants have submitted a petition for a transfer of density units with Petition TDU-20-04 (hereinafter the "TDU Petition") in connection with the above-stated plan amendment, for approval by the Board, requesting a transfer of two (2) units of density to the Property ("RZ"), which is further described in Exhibit "A", attached hereto and by reference incorporated herein, in accordance with the County's Comprehensive Plan and the provisions of the TDU Code; and

WHEREAS, the Certificates of Transferable Density Credits for the density being transferred under Petition TDU-20-04 are attached hereto as Exhibit "B"; and

WHEREAS, the Applicants have submitted all of the information and documentation required for the approval of the TDU Petition pursuant to the TDU Code.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Charlotte County, Florida:

- 1. The TDU Petition submitted by the Applicants requesting the transfer of two (2) units of density to the property described in Exhibit "A", attached hereto and incorporated herein by reference, is hereby approved.
- The effective date of this Resolution shall be the date this Resolution is recorded.
