## Application for Certificate of Public Convenience and Necessity

### Sec. 2-3-49 Application

- (a) Form. The original application for a certificate shall be made on forms approved by the board and to be made available at the county administrator's office. The application shall contain all information required by the board and shall include at least the following.

- (1) The names, business addresses and the experience of both the operator(s) and the owner(s) of the proposed service. If either the owner(s) or operator(s) are part of a corporate entity, the names and addresses of the officers, directors or controlling shareholders of any such corporation must be provided.

- (4) A statement of facts showing the need for the proposed service.

**Being a bridgeless Barrier island and the increased response time of marine unit/EMS response (25 minutes average) it is important to continue providing first response advanced life support service coverage to the residents and guest of LGI. LGIFR currently has a response time of less than 6 minutes to the farthest points of the island.**

- (5) A description of each vehicle to be used in the applicants operations, including the make, model, mileage, all vehicle identification and registration numbers and such further information as may be required by the board.
