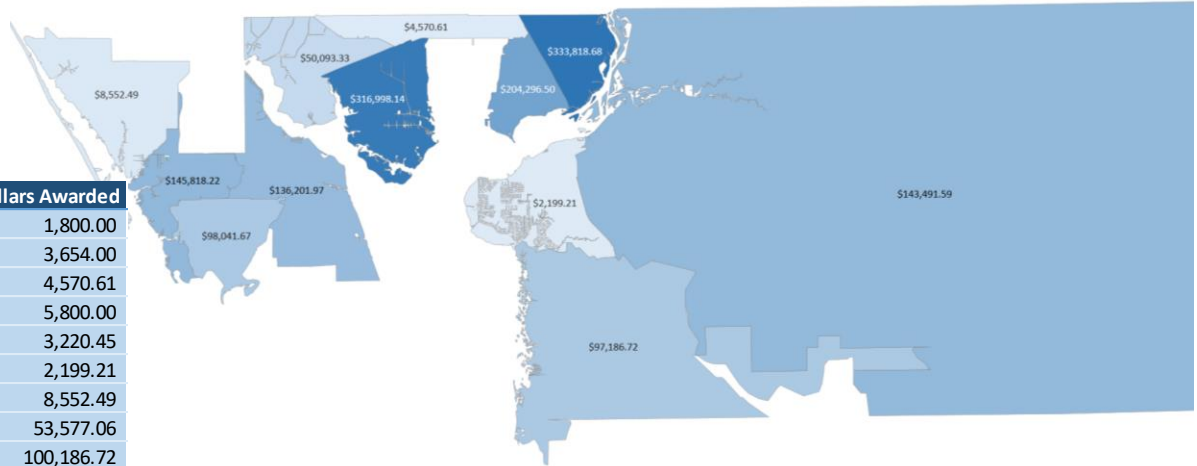

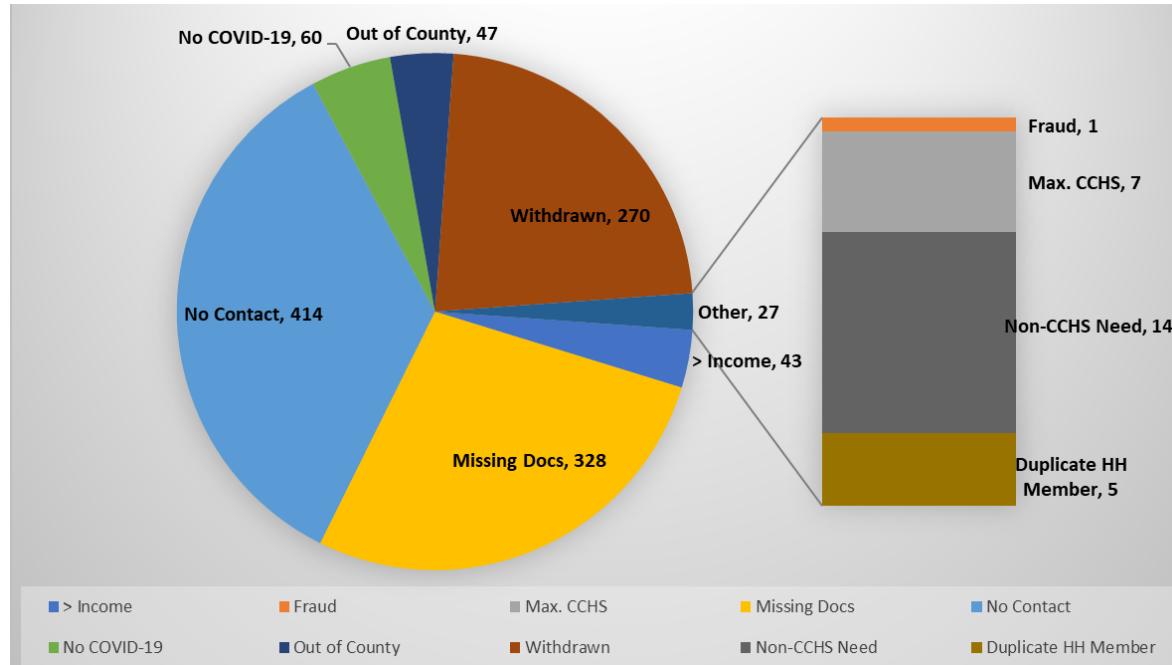

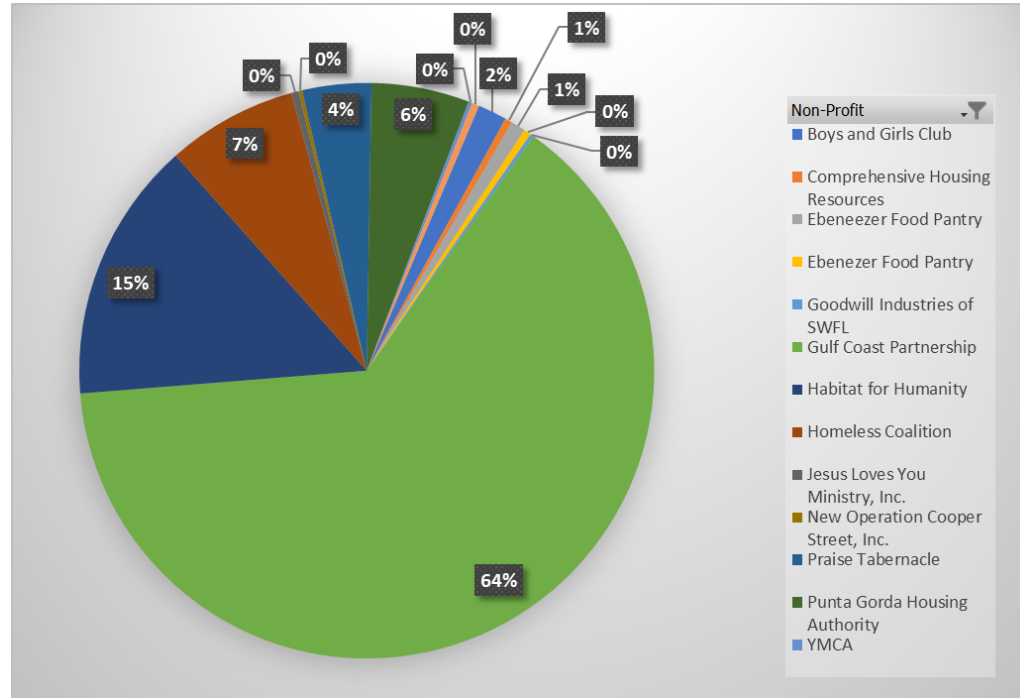

CARES Act Water/Sewer Reimbursement Update

- CCU staff reached out to all 995 delinquent residential accounts
- 431 inquiries received regarding reimbursement
- 296 accounts were researched and assisted or referred
- 44 check reimbursement requests were completed and approved
- **\$16,350.58 total reimbursements processed to date**

Eviction Diversion Program

- Three part program to prevent a large scale eviction event throughout the county
- Limited timeframe (11/2/20-11/16/20)
- Not a rental assistance program
- Within the current CARES act allocation to Human Services and housing

Part 1:

CARES Act individual assistance clients that were approved for financial assistance but are still experiencing significant hardship, specifically, facing eviction. These clients and/or landlords can reach out Charlotte County Human Services and COAD to receive additional assistance of up to \$5000.

- Landlords agree to not pursue eviction for non-payment upon receipt of payment for all past due rent to the date of award.
- CARES act funding is used to pay all past due rent related to impacts of COVID for qualified clients/landlords, or a maximum of \$5,000.00.
- Landlords agree to waive the remainder of rent, fees or charges that exceed the maximum award of \$5000.

Part 2:

Multi-family apartment complexes in Charlotte County that offer affordable units where clients are behind in rent and facing eviction will be contacted by Charlotte County Human Services. CCHS Housing staff currently track occupancy on those affordable (80% AMI and below) units.

- Landlords/Management company will submit their list of affordable tenants and compare to CCHS list of assisted clients to avoid duplication.
- CCHS staff will work with management company to determine how far behind clients may be in rent payments, disclose CARES act funding, track eligibility.
- Management company agrees not to pursue eviction for non-payment upon receipt of payment for all past due rent to the date of award.
- Management company agrees to waive the remainder of rent, fees or charges that exceed the maximum award of \$5000.

Part 3:

Landlords that are registered as sole proprietorship, LLC or a business that can demonstrate a financial loss due to COVID can apply for CARES act funding through the Economic Development Office.
